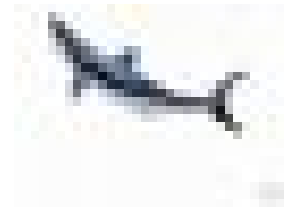

GENERAL TOURNAMENT RULES AND REGULATIONS

1. CAPTAIN'S MEETING : THURSDAY JULY 9th AT 7 pm AT BAHRS LANDING

YOU MUST HAVE A REPRESENTATIVE AT CAPTAIN'S MEETING

2. BOAT LIMIT FIFTY (50) BOATS

3. ENTRY FEE: \$ 200.00 PER BOAT. PLUS CALCUTTA OF \$100.00 ON MAKO SHARK.

4. ALL SHARKS MUST BE OF LEGAL SIZE (34" min) . NO TRANSFERRING FROM ONE BOAT TO ANOTHER.

5. TOURNAMENT COMMITTEE WILL MONITOR CHANNEL #9

6. FISH MUST BE CAUGHT ON ROD AND REEL . ALL IGFA RULES APPLY.

7. IT IS UP TO THE PARTICIPATING CAPTAIN TO DETERMINE WHETHER HIS CRAFT IS SEAWORTHY FOR EXISTING SEA CONDITIONS. THE COMMITTEE CAN CANCEL A FISHING DAY IF SEA CONDITIONS ARE NOT SAFE OR IF SMALL CRAFT WARNINGS HAVE BEEN POSTED. THE CAPTAIN IS RESPONSIBLE FOR THE THE SAFTY OF ALL MEMBERS OF HIS CREW.

8. ONLY ONE SHARK WILL BE WEIGHED IN PER BOAT.

9. PARTICIPANTS CAN FISH ANY TWO DAYS OUT OF THE THREE DAYS

10. ALL PARTICIPANTS MUST CHECK OUT AT BAHRS MARINA. CHECK OUT STARTS 5am EACH DAY . THERE WILL BE NO OVERNIGHT FISHING.

11. WEIGH - IN TIME IS NO LATER THEN 7pm EACH DAY. SCALES OPEN AT 3 pm AND CLOSE AT 7 pm. YOU MUST BE IN SIGHT OF THE MARINA 7pm. YOU MUST CALL MARINA BY RADIO AND GET A CONFIRMATION OF SIGHT BY COMMITTEE MEMBERS.

ALL PARTICIPANTS MUST ABIDE BY THE UNITED COAST GUARD REGULATIONS WHICH THE TOURNAMENT ENDORSES. IN CONSIDERATION OF THE ORGANIZATION PERMITTING ME TO PARTICIPATE IN THE BAHRS LANDING TOURNAMENT, I HEREBY RELEASE BAHRS LANDING FROM ALL INJURIES, DAMAGES OR LOSSES OF ANY NATURE WHATSOEVER IN ANY MANNER CONNECTED DIRECTLY OR INDIRECTLY TO THE TOURNAMENT AND I HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS BAHRS LANDING AND THEIR HELPERS FROM ANY INJURIES, DAMAGES OR LOSSES ARISING OR THAT MAY OCCUR FROM PARTICIPATING IN THE TOURNAMENT. I HAVE READ AND UNDERSTAND THE TOURNAMENT RULES AND REGULATIONS.
